Professor John Wanna is the Sir John Bunting Chair of Public Administration at the Research School of Social Sciences at The Australian National University. He is the director of research for the Australian and New Zealand School of Government (ANZSOG). He is also a joint appointment with the Department of Politics and Public Policy at Griffith University and a principal researcher with two research centres: the Governance and Public Policy Research Centre and the nationally-funded Key Centre in Ethics,

Law, Justice and Governance at Griffith University. Professor Wanna has produced around 20 books including two national text books on policy and public management. He has produced a number of research-based studies on budgeting and financial management including: *Budgetary Management and Control* (1990); *Managing Public Expenditure* (2000), *From Accounting to Accountability* (2001); *Controlling Public Expenditure* (2003); *Yes Premier* (2005); *Westminster Legacies: Democracy and Responsible Government in Asia and the Pacific* (2005); *Westminster Compared* (forthcoming) and most recently *The Reality of Budget Reform in the OECD* (forthcoming). He is completing, with John Butcher and Ben Freyens, a study of service delivery in the Australian government, entitled *Policy in Action* (with UNSW Press). He was a chief investigator in a major Australian Research Council funded study of the Future of Governance in Australia (1999-2001) involving Griffith and the ANU. His research interests include Australian and comparative politics, public expenditure and budgeting, and government-business relations. He also writes on Australian politics in newspapers such as *The Australian*, the *Courier-Mail* and *The Canberra Times* and has been a regular state political commentator on ABC radio and TV.
