Dr Catherine Althaus is currently assistant professor in the School of Public Administration, University of Victoria, Canada and associate research fellow with the Centre for Governance and Public Policy, Griffith University. John Kane is professor in the Department of Politics and Public Policy and Deputy Director of the Research Centre for Governance and Public Policy at Griffith University. He works in political theory, political leadership and foreign

policy. He was awarded (with Haig Patapan) the Mosher Award for best 2006 academic article in *Public Administration Review*. He is the author of *The Politics of Moral Capital* (Cambridge 2001), co-editor of *Rethinking Australian Citizenship* (Cambridge 2000) and *Dissenting Democrats* (Palgrave Macmillan 2008). His latest single-authored work is *Between Virtue and Power: The Persistent Moral Dilemma of US Foreign Policy* (Yale 2008).

David Kemp is a Vice-Chancellor's Fellow at the University of Melbourne and a Professorial Fellow of the Australia and New Zealand School of Government. He was professor of politics at Monash University 1979–1990, a member of Federal Parliament 1990–2004, and after 1996 held a number of Cabinet portfolios. He is the author of *Foundations for Australian Political Analysis* (OUP 1987); *The Reform of Schooling*, in J. Raymond Miller is an associate professor and head of the Department of Politics at the University of Auckland, where he specialises in political parties, representation, electoral systems and elections, and leadership. He has collaborated on a number of election studies, including *Proportional Representation on Trial* (2002) and *Voters' Veto* (2004). His most recent publications include *Party Politics in New Zealand* (2005), *New Zealand Government and Politics* (2006), and *Political Leadership in New Zealand* (2006).

Jan Pakulski, MA (Warsaw), PhD (ANU), ASSA is Professor of Sociology and Dean of Arts at the University of Tasmania. He writes on elites, social inequality, social movements, and social change. He is the author of *Globalising Inequalities* (2004) and *Social Movements* (1991), co-author of *Postmodernisation: Change in Advanced Society* (1992) and *The Death of Class* (1996), and co-editor of *Postcommunist Elites in Eastern Europe* (1998).

Haig Patapan is professor in the Department of Politic and Public Policy and director of the Democracy Program, Centre for Governance and Public Policy, both at Griffith University. His research interests include political theory, leadership, and democratic governance. Professor Patapan is the author of *Judging Democracy* (Cambridge UP 2000) and *Machiavelli in Love: the Modern Politics of Love and Fear* (Lexington 2006); and co-editor of *Globalization and Equality* (Routledge 2004); *Westminster Legacies: Democracy and Responsible Government in Asia and the Pacific* (UNSW Press 2005); and most recently, *Dissident Democrats: the Challenge of Democratic Leadership in Asia* (Palgrave 2008).

Katherine J. Reynolds is an ARC Australian Research Fellow at the ANU. She has also held positions at the ANU as lecturer and senior lecturer teaching Introduction to Organisational Psychology and co-ordinating the postgraduate offerings in Applied Social and Organisational Psychology. Her research has

mainly focused on the impact of social identification processes on stereotyping, prejudice and discrimination; group functioning (for example, motivation, productivity, leadership processes) as well as, more recently, individual psychological functioning (personality, well-being). She is co-editor of *Understanding Prejudice, Racism and Social Conflict* with Professor Augoustinos.

Will Sanders is a senior fellow at The Australian National University's Centre for Aboriginal Economic Policy Research. He previously worked in three other departments of the ANU, focusing his research on public policy towards Indigenous Australians. He has published numerous articles on various aspects of Indigenous affairs policy in the *Australian Journal of Public Administration*, the *Australian Journal of Political Science* and other journals over the last 25 years. His article 'Is home ownership the answer? Indigenous Australians and housing tenure in remote (and settled) areas' recently appeared in the journal *Housing Studies*.

Marian Simms is professor in political studies and served as chair of the politics department, University of Otago, New Zealand from 2002–2007. She recently held a visiting fellowship in the politics discipline, ANU. Amanda Sinclair is foundation professor of management (diversity and change), Melbourne Business School, The University of Melbourne. Her research and teaching is in leadership and ethics, organisational culture and change, gender and diversity and she is the author of several books including *Doing Leadership Differently* (1998, 2004) *New Faces of Leadership* (2002) and *Leadership for the Disillusioned: Beyond Myths and Heroes to Leading that Liberates* (2007). In addition to her work at MBS, Amanda consults to organisations and coaches individuals and senior management teams, is a regular contributor to the business press and also teaches yoga.

Dr Paul Strangio is a senior lecturer in politics in the School of Political and Social Inquiry, Monash University. His most recent books are *No, Prime Minister: Reclaiming Politics from Leaders* (co-authored with James Walter), UNSW Press, 2007; and *The Victorian Premiers, 1856–2006* (co-edited with Brian Costar), Federation Press, 2006.

Emina Subasic is a research fellow in the School of Psychology, ANU. She is also in the process of completing her PhD titled 'Political Solidarity as a Social Change Process: Dynamics of Self-Categorization in Intergroup Power Relations'. Her research focuses on the role of social identity and self-categorization processes in social change, influence and leadership.

John C. Turner is professor of psychology at the School of Psychology, ANU, educated at the University of Sussex and Bristol, he has held positions at the Universities of Bristol and Exeter, Macquarie University, UNSW, and the Institute of Advanced Study at Princeton, before coming to the ANU. His recent works include: *The Citizens' Bargain* (UNSW Press 2002, with Margaret MacLeod), *Ideas and Influence: Social Science and Public Policy in Australia* (UNSW Press 2007, edited with Peter Saunders), and *No, Prime Minister: Reclaiming Politics From Leaders* (UNSW Press 2007, with Paul Strangio).

John Wanna is the ANZSOG Foundation Professor for the Sir John Bunting Chair of Public Administration. Formerly from Griffith University. His research interests include Australian and comparative politics, public expenditure and budgeting and government-business relations. Recent publications include: *Accounting to Accountability* (2001), *Controlling Public Expenditure* (2003) and *Yes Premier* (2005). He edits the Australian Journal of Public Administration, and is general editor of the successful ANZSOG monographs series at ANU E Press, for which he recently (co-)edited the volumes *Australian Political Lives* (2006) and *A Passion for Policy* (2008).

Dr David West is Reader in political science in the School of Social Sciences, ANU. His research and teaching interests include contemporary political theory; Hannah Arendt; Habermas and critical theory; theories of new social movements; and the politics of sexuality. His publications include 'New Social Movements' in *Handbook of Political Theory* (edited by G. F. Gaus and C.
